3. Matters Arising

4. Student Disability Declaration

- 4.1 The Committee considered 'Disability Declarations at the College', produced by the Director of Strategic Planning and presented by the Senior Strategic Planning Officer.
- 4.2 It was reported that, as part of the College's Access and Participation Plan a number of targets have been agreed with the Office for Students (OfS). One of these relates specifically to reducing the gap in non-continuation between disabled students and students with no known disability. The College aims to halve this gap over the next five years.
- 4.3 The OfS set the College a date of 1 July 2020 by which to report on progress towards its targets. However, as a result of COVID-19, this date no longer applies. A new date will be confirmed in due course.
- The Committee noted that steps are underway to identify appropriate interventions at departmental level to reduce the non-continuation rate.
- 4.5 Initial soundings suggest that the apparent gap in non-continuation rates arises not only from the substantive issues facing disabled students, but from a related data issue. The College has low levels of students declaring a disability compared to its peers. Under-reporting of disability status within the College means that those students recorded as disabled are those most likely to be at risk of non-continuation. This issue had previously been discussed at the Disability Action Committee.

important area for the College to address. In order to establish the full extent of the reporting issue, the Committee agreed that further investigation should be undertaken to compare the number of students known to Departments as having a long-term illness, disability or a mental health issue, and the number recorded by the College's Disability Advisory Service (DAS). In addition, it was agreed that advice should be sought from the Deputy Director of Student Services and the Students' Union Deputy President (Welfare).

- **5.2** The Committee noted the following:
 - College initiatives as a result of surveys outcomes are arguably even more important following the increase in online/blended learning and teaching as a result of remote working
 - The College is exploiting technology and EdTech Teams are providing valuable expertise to strengthen the remote learning transition
 - Whilst COVID-19 is a threat, it is also an opportunity to resource future innovation.
